- Acceptance into the show is based on merit and quality of work.
- Open to performers of all ages contingent upon acceptable level of maturity.
- The piece submitted for adjudication must be the piece, if accepted, to be performed at the concert.
- At least 50% of the piece must be performed live for the adjudication panel. The finished piece may be no longer than **5 minutes**. (If you are unable to perform your piece live, a DVD will be accepted providing the choreographer contacts the Dance Alliance prior to February 24, 2012 by 12:00pm.)
- Be prepared to show or explain costume concepts and ideas.
- Due to the small venue, there is a maximum of 12 performers per group.
- Choreographers must be at least 20 years of age.
